Ben - This is a Strategic Plan Committee initiative. It entails keeping the SPC as a standing committee.

C. THE STUDENTS' UNION POLITICAL POLICIES MANUAL

BIMT the Students' Union amend the Policies to include "Policy XXXII - The Students' Union Political Policies Manual" as per handout.

Ben - This is so we have a committee from year to year to help for political initiatives and policy review - universities policy, government policy etc.

Kent - Making a policy about a policy manual is stupid.
 Jason - This will be good for next year's council to look at.

Ben - If we are the primary organizer we don't need an exchange of funds.

Jason - Canada World Youth came to the Anti Racism event and we were the primary organizers. This is formalizing anything that doesn't fall under our umbrella.

Kent - We will be restricting ourselves and if we don't leave #5 in I think it's pointless.

Talis - It could be worded to say "not intended to be" instead of "cannot".

Kent - #7 - I don't like the idea of counting volunteer time and people won't follow it anyway.

Charlotte - It's the same as any other thing - to be accountable to the hours put in.

Talis - I think it's a good idea to count hours, but not strictly. It would be more motivation to put in time.

Stephen - #6 - I don't like how it gives the option, it's too vague.

Jason - #6 - doesn't need to be in here, I find it redundant.

Tyler - It's important to read this. We can't take these changes lightly.

Nic - If we agree as a General Assembly maybe we could meet Friday and

have a discussion on it.

Tyler - GA meetings have to be at least 2 weeks apart.

Jason - We could give ourselves 2 weeks and then have constructive

conversations.

Charlotte - It's definitely a good idea to go over it better, the committee is meeting

tomorrow.

Kent - If we don't go over each one we could overlook what Ben has done

here.

Charlotte - In #11, is it suppose to say VP Academic?

Ben - No it's suppose to say "President", it's a typo.

Ben - I'll make a not to include the entire General Assembly.

L. **DIRECTORS** - REMOVAL OF BYLAW

BIMT the Students' Union remove "Bylaw XI - Directors", eliminating the Director positions.

Ben - There is no insert for this one, it's just removing the Bylaw of

Directors. It is nice to have a GA eye in the Executive Council

meetings, as a fail safe.

Stephen - I think the Directors are very important and could be utilized more.

M. HONORARIA

BIMT the Students' Union amend "Bylaw XVII - Honoraria", as per insert 12.8M, pg 58

Ben - This is one that offers a small raise and one that has no raise but a

reduction of role. There will be an honoraria increase if we pass it.

Kent - Should there be a point in there to include cost of living inflation?

N. DIVERSITY REPRESENTATIVES

BIMT the Students' Union amend the bylaws to include "Bylaw XXX - the Diversity Representatives", as per insert 12.8H, pg 31.

(N1) Ben - Even if these positions don't get filled, at least they will be

open. They will be expected to sit on university things too.

Nic - I totally disagree with this. I'm worried there will be special

interest all over the place. They can be on the General Assembly already. We already have a problem filling

positions.

Kent - I like Nic's point. They can come in them selves and speak to

us as is.

Andrew - I think we should keep the General Diversity Rep only. That

one person could represent everyone.

Ben - Disabled students have an office on campus.

Kent - I'm not saying I dislike the Diversity position, I think it would

be usles to have one for each group. I agree with Andrew.

Jason - I think we should save qualitative debate for later.

(N2) Ben - This is saying that anyone can vote for these positions.

O. ELECTION, REFERENDUM, AND PLEBISCITE BYLAW

BIMT the Students' Union amend "Bylaw XXIV - Election, Referendum and Plebiscite Bylaw" as per insert 12.8F, pg 31.

Ben - The change is changing it to 40 hours.

Stephen - I think 1 hr/day for Directors is small.

Ben - Give them an honoraria increase and tuition allowance.

Jason - I take it as an insult that we are increasing the honoraria and working

longer when we already work longer than 35 hours per week. There really wouldn't be any financial increase if more hours are required.

Andrew - Taking one course really isn't going to school. I really think if they

want to work and go to school they should have that option.

Kelly - What do other universities do?

Ben	-	One, is that the more courses you are enrolled in, the better student perspective you have. Two, is that the less courses you are enrolled in
		the more work you can get done.
Kelly	-	I don't know how you have three classes and do all the work you do. I
		don't think there should be a course load difference between the
		President and the VP's. It should be the same across the board.
Kent	-	Lowering it to 2 from 3 you are encouraging students to stay with the
		SU longer.
Gaurav	-	If you are serious about your job there is good and bad to it. Depends
		who gets voted in.
Jon	-	Tuition allowance would be taxed and the elective would be eligible for
		the Health and Dental plan.
