The Canadian Alliance of Student Associations hosted their annual Advocacy Week from November 25 -30. To say I am not exhausted, would be an understatement. This week was amazing from beginning.

student leaders and advocates from all over the country. As a member of the Board of Directors



for CASA, I had a pretty good idea what to expect from the week, but it definitely exceeded all expectations. I am so thankful for my fellow Board members and the CASA home office staff. Without months of dedicated work, this advocacy week would not have been what it was. CASA had over 150 meetings on Parliament Hill with MPs,

Senators, and Stakeholders. We took 6 really important asks to the Hill, which ranged from advocating for changes to immigration legislation to improve post-secondary access for international students, talking about how important work integrated learning is, and even

advocating for a standard be set for gender based sexual violence policies across the country. All in all, we advocated on behalf of about 350,000 students from across Canada, and that's something to be incredibly proud of.

The first couple of days of the conference were for learning and preparing. CASA has a strong reputation of ensuring that our delegates are prepared and professional in and out of meetings. Thanks to the home office staff and external bodies, we were able to ensure that our delegates had all of the tools they needed to succeed. On the 26th, I had the opportunity to take over the CASA Instagram Story and

On Tuesday, we hit the Hill for 3 crazy days of meetings. I was in a total of 7 meetings, while president Laura Bryan had 8. Laura and I had the pleasure of meeting with MP Rachael Harder for the first time. MP Harder is my MP and the MP for the City of Lethbridge. It was

As a Political Science nerd, and someone who adores Canadian Foreign Policy, I also ran into Minister Chrystia Freeland while she was on a run. They say Ottawa is the smallest town ever, and I learned this week that sentiment is true!



In addition to meetings, I worked with CASA's Policy Analyst, John, to run a session with our policy committees to gauge our next steps and to talk about what is going well and what needs to change. This session was really well attended and John and I took a lot from it. We will be sitting down and going through all of the feedback with how we would like to structure things from here on out.
