WHAT IS CASA? & WHY ARE WE APART

CASA is a national voice for Canada's post-secondary students. CASA is a non-partisan, not-for-profit student organization composed of student associations from across Canada. They represent undergraduate, graduate and polytechnic associations.

CASA advocates on behalf of post-secondary students to the federal government. When Canada's leaders make decisions affecting our post-secondary education system, they look to the student representative from the different post secondary institution apart CASA for solutions.

Currently CASA has 23 member schools and represents over 365,000 students across the country.

History of CASA & ULSU

CASA officially became a lobbying body on June 27, 1995. Upon being founded the ULSU was one of the 12 members of CASA when they were found. Since then, the ULSU has been active members and participants of CASA and have been instrumental in the enusuring that students are at the fore front of our advocacy efforts. Recently the ULSU has had delegates sit on CASA's Board of Directors, namely as Treasurer and Director of EDI.

Day one of the CASA foundation conference began with an opening smudging ceremony and blessing from elder. We then went into discussion surrounding our advocacy priorites for our different schools. For the ULSU our advocacy priorities centers student student grants and funding, food security, housing security, mental health, students and Open educational resources. Following this we had mock advocacy meetings to test how we operate when we advocate for our students on the specific needs. We then met the Co-chairs for the National Indigenous Advocacy Committee to discuss how we engage and advocate for our Indigenous students.













On day three, President Maleeka and VP External Rachele Preston engaged in meaningful discussions with other member schools surrounding policies and issues that our respective student body is facing. We also heard from Parliamentary Secretary Irek Kusmierczyk who gave us an overview as to federal advocating procedures and how to maximize meetings that we have with different governmental officials. Additionally, they were able to share insights on how to remain non-partisan and be student driven and focused especially when advocating to federal government. Lastly, CASA delegates got the opportunity to sit in on Question Period on Parliament Hill.
