- A PhD candidate from the Department of Sociology at the University of Calgary
  has reached out to council members to be interviewed for a research project on
  intergroup relations and the general climate for students from different cultural
  backgrounds on Canadian university campuses.
- Their general focus of study is intergroup conflict, violence and religion.
- This is a unique opportunity to insert the ULSU perspective into formal research on social dynamics within post-secondary institutions.
- Limited academic studies have been done on interrelationships and EDI within post-secondary settings. It is important to offer as much student perspective as possible. This study could be used to influence government decisions in the future.
