Board of Governors

The February Board meeting was the longest of the year so far, taking over four and a half hours. And this was for good reasoning. There were a number of important matters to discuss – namely that of Student Fees and Tuition for the 2020 academic year. There was a very healthy and candid conversation around the Board. Obviously the political environment which led us to be in this situation is unfortunate to say the least. I did my best to communicate to the board the value of accessible post-secondary education - with everything from the barriers it reduces to the competitive advantage out current tuition grants our institution. Despite this, the fees and tuition documents were eventually approved by the board. I believe this challenging meeting illustrates the critical importance of advocating clearly and openly with the government. Unfortunately, by the time large scale decisions get made by the government, possecondary institutions are placed in a situation where their options are limited. As the majority of expenses are tied up in salaries and majority of revenues (beyond the CAG) come from tuition, the university is placed in a situation where they have to quickly increase revenues or decrease expenses; both of which lead to potentially destructive decisions affecting multiple people. While we did our best to communicate this to the government in addition to many other messages outlining the importance of a post-secondary education, damaging decisions were still made. These decisions still having lasting impacts on our institution. I will be working diligently with the incoming President and VP External to communicate this value of advocacy and ensure we have representatives who are able to communicate with government in a way which limits these destructive decisions before it is too late.

CASA SuperCon 2020

The final CASA conference of my term was not a short one. Bailey and I flew out to Ottawa for eight days with the key goal of advocating to the federal government. As it is SuperCon, we also had the CASA Annual General Meeting. I would expand more here, however; I will direct you to my travel report which outlines this conference in much greater detail including the six specific priorities we talked to the government about.

Townhall Speeches

It was a bittersweet honor to attend this year's townhall speeches. Bittersweet because I cannot express how proud I am of all candidates, however; it is also difficult to communicate the feeling of knowing you will not be coming back to this organization. I have thoroughly enjoyed my experience as President this year, but I am ready to pass along the title and encourage the further betterment of this organization. I wish all candidates the best of luck moving into the voting part of elections.
