9.1 PUBLIC ART INITIATIVE – Demi

<u>Annie</u> - A lot of students came up to our table at Mental Health tabling saying that they are starting to notice what the SU is doing. They are beginning to appreciate our advocacy, events, and initiatives.

<u>Ilham:</u> I feel like \$15.00 may be a bit high to ask for the referendum, would we consider assessing \$10.00?

Angelina: I think the \$15.00 is a reasonable amount, is the 5% on top of the CPI? Maleeka said she will discuss with the accountant and verify that information. I think the fee should be reviewed within a certain time frame with GA. Come to review at the AGM in line with our Strategic Plan. Moyo: Had a similar question about 5%.

<u>Bradley</u>: 5% seems a little high, just wondering where that % came from? Maleeka compared it to other Students' Union fees across the province.

9.3 UPASS UPDATE - Maleeka/Cheri

Maleeka: I met with the union rep for the Lethbridge Transit bus drivers. They are currently on strike due to changes in the bus routes and also their admin. They are starting a coalition to physically protest at city hall, and they want students to be a part of the coalition of protestors. I don't think we choose a side, but our mandate is to always advocate for the students. A discussion ensued.

<u>Angelina</u>: I think based on the limited amount of information, it doesn't seem like it's up to us to take a stand. Perhaps we need to just make a statement release.
