Within this last month, I've been able to be a part of many university committees before the end for the summer. I have also able to advance my portfolio a bit more for the month. Here are some of the highlights for this month:

#### **General Faculties Council**

In this meeting we were able to approve some important curriculum changes to a few faculties and majors. We also reviewed a proposal to create a Genome Sciences Centre on campus, which was approved as well. This is an exciting step forward for science research at the University of Lethbridge.

We reviewed a new final grade appeals procedure which is significantly different from the past one. This was approved, and now it is our role to help students with this new system of grade appeals. Our student discipline policy was also updated during this meeting to give more authority on situations on campus. More specifically we approved updates to both the Sexual Violence Policy and the Harassment and Discrimination Policy.

Finally, we were able to take an in depth look at our progress with the Destination Project, our Progress and Achievement Report of the UofL Strategic Plan and the 2019-20 Budget. Many of the things reviewed during this meeting have exciting challenges and prospects for the university and I was happy to be a part of it.

### **Sexual Violence Policy Meeting**

This meeting, between the ULSU executive, the GSA president and Kathleen Massey, the AVP Students in regards to the new Sexual Violence Policy passed through the Board of Governors recently. There was plenty of discussion on what situations would apply this policy and what wouldn't. We discussed how this would affect events on and off campus as well, as certain events could still be tied to the University, such as club events.

#### **UPass Meeting**

This meeting was done between myself, Andrew, Carrie Takeyasu and Marnie Sawa from the Finance Department of the University. We discussed the current Memorandum of

### **Project Paintbrush**

### **Board of Governors Retreat**

At the end of the tour, we were able to go and have dinner in one of the halls of the building, after which we were given a presentation on the challenges and benefits of being able to work in such an advanced, new building.
