#### Meetings with Adv. Education Minister Nicolaides

THE UNIVERSITY OF LETHBRIDGE STUDENTS' UNION

I met with Minister Nicolaides on two occasions. The first time was with the rest of the ULSU executives to introduce ourselves, and the second was with a number of student leaders from student associations and organizations to discuss the Government of Alberta's COVID-19 Relaunch Plan, as well as the implementation Investment Management Agreements and Performance Based Funding. At the time of writing the implementation has been delayed for at least a year, which I believe is a good step in order to allow post-secondary institutions the ability to focus on pandemic response measures.

#### Advising Working Group

VP Academic Liam Connel and I had the opportunity to sit on this working group. Made up of people across the university community and the various advising offices, this group was focused on analyzing the format and structure of advising at the UofL, as well as developing a new model for the future. Some preliminary work has been done, and Liam now sits on a subgroup developing our ideas further.

### CAUS Changeover Conference

The Council of Alberta University Students (CAUS), is our provincial lobbying group, on which VP External Ryan Lindblad and I are the primary and secondary delegates, respectively. This conference, usually held in-person, ran over the course of four days and was a chance for the previous delegate to give training and share their advice on how to advocate on behalf of the university students across Alberta. Our Chair and Vice-Chair were also elected, and I look forward to advocating on behalf of the undergraduate students to the provincial government in the year to come.
