This month has definitively left the Students' Union with a challenge. The release of the provincial budget at the end of October has left the office with a workload persisting through this month and beyond. Given that, here are some of the highlights for this month:

#### **General Faculties Council**

In this meeting there was a lengthy discussion on the Budget and it's implications for the university. We then able to make some lengthy Bylaw Amendments related to the Executive and Quality Assurance. After reviewing some reports, the meeting was led into another important step. The Freedom of Expression statement of the university was reviewed and much of the meeting was left on this point.

#### Legislative Review Committee

The Legislative Review Committee had its first meeting this month. In this meeting I was able to establish the purpose of the committee and give them the tools to succeed as members. We had decided in this meeting to divide the sections of the Operations Manual between each member, give each person an equal share. Afterwards, we had a full discussion on some of the goals that we had for improving the manual. I am looking forward to what we can achieve.

#### Arts and Science Council

This meeting was a fairly short one. Aside from reports we were able to vote on some curriculum changes for Arts and Science. This included Biology, Chemistry and Biochemistry, First Nations' Transition Program, Geography and Environment, Indigenous Studies, Kinesiology, Mathematics and Computer Science, Neuroscience and Sociology. These changes will be brought to GFC in December.

#### **CAUS Counterparts Fall Conference**

This semester we travelled to Edmonton for our CAUS Counterparts Conference. Many of the sessions were useful to the overall portfolio of a Student Association Executive. We had sessions on Strategic Planning, Advocacy, Life after being an Exec, OERs, Council Accountability, Transition Planning, and many more. As well I was able to meet with the VP
